

## **BAB 6**

### **KESIMPULAN**

Pada empat semester pertama Jurusan Musik ISI Yogyakarta memiliki tiga program yang berbeda. Walaupun demikian Jurusan menerapkan 14 tingkat keterampilan gitar klasik. Materi kuliah yang digunakan ialah ketujuh modul kurikulum yang ditemukan dalam penelitian ini. Dengan demikian setiap modul digunakan untuk dua tingkatan. Urut-urutan tingkatan tersebut digunakan secara berbeda pada ketiga program studi musik. Temuan penelitian ini memberitahukan kepada kita bahwa sejak awal pendiriannya ISI Yogyakarta sudah memiliki system dan model pembelajaran yang sistematis dan terukur. Taksonomi keterampilan gitar klasik yang ditemukan dalam penelitian ini dapat dijadikan sebagai model dalam mengatasi permasalahan kurikulum saat ini sehingga dapat menghasilkan proses belajar yang fair di antara keempat program studi musik saat ini.
